WAITING LIST. LETTINGS AND INSPECTIONS

There were 34 people on the waiting list and **SP** had written to the individual plotholders whose plots had been causing concern.

A banner advertising the show had been put up and preparations for the show were progressing well. **SP** had put out boxes for members' donations of produce and there would be a cinema on **SM's** plot. There would be activities for children on the community plot.

NAWG MATTERS INCLUDING THE CITY SHOW

The City Show would take place on 15 September, when winners in the City competition would be awarded their prizes. **SP** would be collecting produce for the event and would attend the show as the Moorside representative.

ANY OTHER BUSINESS

- ♦ It was agreed to aim to hold the 2020 AGM in early February. This would allow for the paperwork to be distributed in January, after Christmas.
