The tenant of plot 10 expressed a wish to erect a greenhouse but two problems would have to be addressed, viz. trees and a culvert at the back of the plot. It was agreed that sapling trees could be removed and crown lifting where possible. FL would contact the tenant.

The tenant of plot 97 had spoken to SJ regarding trees overshadowing the front of his garden. FL would inspect them.

TW to confirm with the tenant of plot 46 that he could not have two plots in the city and seek clarification that their former allotment plot on another site had been given up.

The Comfrey Project had appointed a new co-ordinator.
